

## **Declaration of Consent for the Processing of Personal Data**

- **8.** My personal data will be kept for different periods of time, depending on the purpose for which it is intended, but always only for the minimum period necessary for the purpose of its collection and processing, fulfillment of legal obligations or, as long as consent is not withdrawn. By the expiration date, my data will be securely deleted or anonymised, if possible.
